Suitable documentation: To waive the late fee or to receive a prorated fee, only the date on the following documents can be used - lease, title/mortgage, vehicle registration date, auto dealer bill of sale, vehicle title, IDOR vehicle tax forms. Chicago, Ill. § 3-56-050 (2006).

Late fee: June 1st through July 15th no late fee applies. July 16th through May 31st a \$40 late fee applies unless the suitable documentation proves the applicant moved to Chicago or purchased the vehicle within the last 30 days.

Fee: The date on the suitable documentation (see list above) is used to determine the date range for the appropriate fee. For example, if the date on the vehicle registration for a larger passenger vehicle is February 15th it falls between December 1st and March 31st so the prorated fee is \$80. If the applicant provides no documentation, charge the full fee listed under June 1st through November 30th.

Remember to add the late fee, if applicable, to the appropriate fee.
